ZIMBABWE CONFORMITY ASSESSMENT FOR USED VEHICLES NOW MANDATORY

Kindly note that Bureau Veritas has been appointed by the Ministry of Industry & Commerce Zimbabwe for the provision of the Consignment Based Conformity Assessment (CBCA) program applicable to some categories of used vehicles imported into Zimbabwe from the 1st of June 2022.

The objective of this program is to:

- Protect consumers against dangerous, sub-standard vehicles
- Improve quality of products through compliance with applicable standards and regulations
- Facilitate trade operations by recognising existing conformity proof to avoid unnecessary checking
- Ensure swift clearance with customs.

Shipments arriving without the required certificate of conformity will be subjected to penalties. It is then strongly recommended to comply to avoid rejection, delays and extra costs on arrival.

EXPORTER REQUEST PROCESS:

1. Visit zwv.bureauveritas.com to make an online application and payment or send the following information to conformity.zimbabwe@bureauveritas.com:
2. Request for Certificate (RFC Form)
3. Exporter Declaration (Exporter declares the list of vehicles, make, model, VIN, last country of use)
4. Vehicle ownership documents or deregistration documents
5. Copy of last roadworthiness certificate/report (if available)
